Membership renewal for year ending 31 March 2026

Your current membership expires on 1 April 2025 and is now due for renewal. We hope that you enjoy being a member of the Society and wish to renew your membership for the coming year. If you joined the Society since 1 January 2025 your membership is valid until 31 March 2026 and therefore no action is required.

We have regretfully had to increase UK postal membership by £2 as costs continue to rise in our core areas of print and mailing. However e-membership, with magazines received only via download, has been reduced by £8 to £20. We continue to believe that the NGRS offers excellent value compared to commercial publications or similar railway enthusiast society subscriptions and hopes for your continuing support.

The 2025/26 Membership options and rates are as listed below:

Full memberships provide printed copies of The Narrow Gauge (TNG) and up to six issues of Narrow Gauge News (NGN) plus any one-time books published by the Society. Other members of a family household may become **Associate members** enabling them to attend Society visits, the AGM and visit the Society library based at Apedale. Please be aware that an Associate member will not receive any publications.

E-memberships provide online access to TNG and NGN magazines via a members only section of our website.

Visits & e-NGN memberships are eligible for participation in Society visits and will receive NGN online.

How to renew your membership

If you do not renew by direct debit and have provided a current email address you will have received a renewal email explaining how to renew your membership **online** using bank transfer, debit card, credit card or payment using PayPal or a Stripe.

If you did not receive a renewal email, you are able to renew online provided you have an email address associated with your membership record by using the process below: -

Visit the Society website at www.ngrs.org/membership and click on the **Renew** button to access the Membermojo database. Enter your registered email address and follow the prompts.

You may also pay for your membership subscription using bank transfer (BACS) or personal cheque.

BACS payments should be made to Narrow Gauge Railway Society sort code 54-41-37, account number 50786083. Please quote your postcode as the payment reference so that we can identify you as the payee. For cheque payment use the renewal slip below. Your cheque should be made payable to "Narrow Gauge Railway Society" (drawn on a UK bank and payable in sterling).

Several members have asked if they can make a voluntary donation to the Society at the same time as they renew. Should you wish to make a voluntary donation you can do this either as part of your online renewal or your cheque.
